- John Cottee (Nottinghamshire County Councillor and chair of Inspire Board) welcomed members to the second in-person and online Inspire AGM. He explained how members could ask questions, vote and made everyone aware that the event was being recorded for minuting purposes.
- John Cottee asked for members to raise any items for Any Other Business. No questions or comments received either online or from the library meeting.

# 4. Presentation of the Annual Review

- Peter Gaw (Inspire, Chief Executive Officer) thanked staff, members, and partners for their fantastic work and highlighted some of the achievements in the year including the <u>Inspire Learning Annual Prospectus</u>, the libraries and culture <u>What's On Brochure</u>, <u>Inspire Youth Arts 25 Year</u>s celebration brochure and the <u>Community Makers</u> volunteer programme.
- Presentation of the <u>2021 22 Annual Review video</u>

#### 5. To receive and approve the Trustees' Report and Financial Statements for the year ended 31 March 2022

• Margaret Anderson (Inspire, Chief Finance Officer) was pleased to report that Inspire continues to be 'a going concern' and that the financial statements for the year ended 31<sup>st</sup> March 2022 have been prepared, audited and filed with the Financial Conduct Authority (FCA).



- Inspire's Statement of Financial Activities shows a deficit of £1,581,992 after an actuary pension adjustment of £2,047,000. The Chief Finance Officer explained to members how Inspire is required to report on the liabilities of the Local Government Pension Scheme and reassured them that as long as Inspire continues to operate and has contributing members then the pension liability cannot be called in.
- By stripping out the pension adjustments Inspire's activities over the year reveal a surplus of £465,078. Margaret Anderson explained how this surplus is made up of restricted, unrestricted and fixed asset funds and how and when these are used along with summaries of where the Society's money came from and how it was spent.
- No comments or questions were received either online or from the library meeting.
- Members were asked to approve the Annual Report and Audited Accounts for the year ended 31<sup>st</sup> March 2022.
